Notice to Award Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Ka'u Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract with Carol Myrianthis d.b.a Kinesis Hawaii, Inc. HHSC desires to award the Agreement so as to allow Kinesis Hawaii, Inc. to provide physical therapy services for a twelve-month period. Carol Myrianthis was appointed to the East Hawaii Region Board of Directors in June 2008 and will serve a term of four (4) years.

Ka'u Hospital, designated as a Critical Access Hospital in July 2001, serves a critical role in the delivery of health care in the vast rural area located approximately twenty-five miles beyond Volcanoes National Park Headquarters on the Island of Hawaii. As a Critical Access Hospital, it serves as a provider of patient care in its geographic service area. Because of the isolated location of the Hospital, it has always had difficulty recruiting or retaining sufficient numbers of qualified physical therapists to provide the necessary coverage for its patients.

The Scope of Services to be performed by Carol Myrianthis d.b.a. Kinesis Hawaii, Inc. includes:

Provide physical therapy services at the Ka'u Hospital to inpatients on an as needed basis. Services that are provided must comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission on Accreditation of Healthcare Organizations ("JCAHO");
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.

Time of Performance

Carol Myrianthis d.b.a. Kinesis Hawaii, Inc.'s time of performance is anticipated to begin May 14, 2012 through and including May 13, 2013. This is the second contract extension of four (4). There are two (2) one-year options remaining to extend this agreement.

Contract Amount

The Not to Exceed Value of the contract is Twenty Thousand and 00/100 Dollars (\$20,000.00).
