Notice of Intent to Extend Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kona Community Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to extend its contract with Rodger C. Kollmorgen, M.D., Ph.D., JD. for Medical Director services for the Hospital's Inpatient Behavioral Health Unit. Rodger C. Kollmorgen, M.D., Ph.D., JD. serves as a full time employee with the Hawaii Department of Health as an attending Psychiatrist.

Kona Community Hospital, the primary health care facility serving West Hawaii, is a 94-bed full service medical center located 18 miles south of Kona International Airport in Kealahou Hawaii. The Hospital is in need of a Medical Director for the Behavioral Health Unit that is familiar with the legal system and has determined that Dr. Kollmorgen best meets this need.

The Scope of Services to be performed by Rodger C. Kollmorgen, M.D., Ph.D., JD. includes:

Provide Behavioral Health Medical Director services at Kona Community Hospital. To coordinate, supervise, and evaluate the medical services provided in the Department and operate the Department in compliance with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.

Time of Performance


The Time of Performance for this Medical Director Physician contract amendment between Rodger C. Kollmorgen, M.D., Ph.D., JD. and Kona Community Hospital extends the term of the agreement for an additional one year term and shall be in effect from July 30, 2011 until, and including, July 29, 2013.

Contract Amount

The total contract not to exceed amount is \$120,000.00. The original contract had a not to exceed amount of \$60,000.00. The first amendment increases the not to exceed amount an additional \$60,000.00.
