Governor Appoints Dawn Suyenaga and Carl Morton to the Hawaii State Ethics Commission



Governor Cayetano has appointed Dawn Suyenaga and Dr. Carl Morton as the newest members of the Hawaii State Ethics Commission.

State Officials Report Gifts Received on Annual Gifts Disclosure Statements

June 30, 1999 was the deadline for state officials to file gifts disclosure statements with the Hawaii State Ethics Commission for gifts received during the period from June 1, 1998 to June 1, 1999. The State Ethics Code requires state legislators, employees, and board and commission members to file annual gifts disclosure statements with the Commission if they meet <u>all</u> of the following conditions:

- The individual or a spouse or dependent child receives from one source (a) any gift greater than \$200, or (b) gifts whose combined value is greater than \$200;
- The source of the gift or gifts has interests that may be affected by official action or lack of action by the individual; and
- 3. The gift(s) is not exempted from the disclosure requirements by the ethics code.

The Commission distributed information about the gifts disclosure requirements and reminders about the filing deadline to all state agencies earlier this year. State officials who did not receive any reportable gifts during the reporting period were not required to file a gifts disclosure statement with the Commission.

This year, state officials reported receiving gifts that included airfare, lodging, and ground transportation for trips; registration fees for conferences; food and beverages; tickets and passes to special events; internet access and e-mail accounts; and books and publications. All gifts disclosure statements filed with the Commission are public records.



Applications Being Accepted for Ethics Staff Attorney

The Hawaii State Ethics Commission is accepting applications for a staff attorney. Job duties and application requirements are as follows:

Minimum qualifications: JD or LLB degree, member of Hawaii Bar. Major duties include: Researching and writing legal opinions; advising state officials, state employees, and the public on the State Ethics Code (chapter 84, HRS) and the Lobbyists Law (chapter 97,

HRS); conducting investigations; representing complainants Commission or the in hearings; administrative drafting legal documents relating to complaints; educational activities; reviewing disclosure documents and other documents filed with the Commission for compliance with the law; preparing documents for Commission meetings; drafting proposed legislation and legislative testimony, and administrative duties. Much handling of confidential information. Writing ability is particularly important. Salary to \$47,000/year. Question: You recently retired from your job as a state employee. Your former state department would like to hire you back temporarily to complete a special project. Do the ethics laws allow the department to contract with you for your services?

Answer: Yes. The ethics laws impose certain restrictions on former state employees. These "post employment restrictions" include prohibitions against representing others, for compensation, on certain matters. But these restrictions do <u>not</u> prohibit any state agency from contracting with a former employee to act on a matter on behalf of the State, and do <u>not</u> prevent a former employee from appearing before any agency in relation to such employment. (HRS § 84-18(d))
