Each member must be a U.S. citizen and a resident of Hawaii. The members of the Commission volunteer their time and service to promote high standards of ethical conduct in state government.

Meet the current members of the Hawaii State Ethics Commission:

Maria J. Sullivan, Esq., Chair. Ms. Sullivan is an attorney with her own private law practice. She obtained her law degree from Seattle University School of Law. Before moving to Hawaii, Ms. Sullivan was an Assistant Attorney General for the Washington State Office of the Attorney General. She also previously served as the Senior Disciplinary Counsel for the Washington State Bar Association Office of Disciplinary Counsel.

Terrific Response to Summer Ethics Classes!



Ask nearly 600 state employees what they did this summer and they may tell you that they attended an ethics training class. The State Ethics Commission held ethics classes in July and August for state employees on Oahu, the Big Island (Hilo and Kona), Maui, and Kauai. Response to the classes was overwhelming. On Oahu, ethics training was held at the Hawaii Convention Center to accommodate over 250 employees who signed up to learn about the State ethics laws. The training sessions covered important ethics laws relating to gifts, conflicts of interests, misuse of official position, and post-employment restrictions. Ethics training sessions will be offered on Oahu and the neighbor islands annually. Mahalo to all employees who attended ethics classes this summer!

Ethics Guidelines for Gifts

The Hawaii State Ethics Commission has issued a new publication called, "Guidelines for Gifts Under the State Ethics Code." This publication discusses the gifts law and how it applies to state legislators and employees. The gifts guidelines are intended to assist individuals in understanding and navigating the gifts law.

The gifts guidelines discuss a variety of gifts. These include: "Gifts of Aloha" and other small gifts that may be accepted, such as a box of candy or malasadas for the office; meals and other "food and drink" events, including receptions, "meet and greet" types of events, and fundraiser dinners; "activity-related" gifts, such as golf and tickets to movies and shows; and gifts that are travel-related, such as airfare or hotel accommodations.

The State Ethics Commission recognized the importance to the State in hosting the APEC Forum and viewed the legislators' participation in APEC-related events to be of benefit to the State. The Commission advised the Hawaii Host Committee that the acceptance of the invitations by legislators would not raise concerns under the State Ethics Code.
