**Notice of Intent to Extend Contract**

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kona Community Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to extend its contract with Rodger C. Kollmorgen, M.D. for On Call Physician services for the Hospital's Inpatient Behavioral Health Unit at the Kona Community Hospital. Rodger C. Kollmorgen, M.D. serves as a part time employee with the Hawaii Department of Health as an attending Psychiatrist.

**The Scope of Services to be performed by Rodger C. Kollmorgen, M.D. includes:**

Provide On Call coverage for the Behavioral Health Unit at Kona Community Hospital in accordance with the call coverage schedule established by the HOSPITAL.

**Comply with:**

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.
6. Respond to and be available in the Hospital as soon as possible within 30 minutes of the request to provide care for patients at the Hospital.

**Time of Performance**

The Time of Performance for this On Call Physician Agreement amendment between Rodger C. Kollmorgen M.D. and Kona Community Hospital shall be from April 16, 2010 until, and including, April 15, 2011.

**Contract Amount**

The total contract Not-to-Exceed amount is \$137,000. The original contract had a not to exceed amount of \$50,000, the first extension increased the not-to-exceed amount an additional \$27,000. This second extension increases the agreement an additional \$60,000.


Anyone wishing to protest the award of this contract shall submit an objection, in writing, no later than 4:30 p.m. on Friday, April 9, 2010, to:
