Notice to Amend Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Ka'u Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to amend its contract with Joshua Booth Green MD. HHSC desires to continue its Agreement with Joshua Booth Green MD to provide on-call emergency room services for a twelve-month period at the Ka'u Hospital. Joshua Booth Green MD was elected to the Hawaii State Legislature, House of Representatives and serves the 6th Representative District.

Ka'u Hospital, designated as a Critical Access Hospital in July 2001, serves a critical role in the delivery of health care in the vast rural area located approximately twenty-five miles beyond Volcanoes National Park Headquarters on the Island of Hawaii. As a Critical Access Hospital, it serves as a provider of patient care in its geographic service area. Because of the isolated location of the Hospital, it has always had difficulty recruiting or retaining sufficient numbers of qualified physical therapists to provide the necessary coverage for its patients.

The Scope of Services to be performed by Joshua Booth Green MD includes:

Provide on-call emergency room physician services at Ka'u Hospital on an as needed basis. Services that are provided must comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.

Time of Performance

The Time of Performance for this On-Call Emergency Room Physicians Agreement between Joshua Booth Green MD and Kau Hospital shall be from May 24, 2010 until, up and including, May 23, 2011.

Contract Amount

The Not to Exceed Value of the contract is Sixty Eight Thousand and 00/100 Dollars (\$68,000.00).

Anyone wishing to protest the award of this contract shall submit an objection, in writing, no later than 4:30 p.m. on Wednesday, May 12, 2010, to:
