## **Notice to Amend Contract**

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of East Hawaii Region a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to amend its contract with Dennis Lee, M.D. HHSC desires to continue its Agreement with Dennis Lee, M.D. to provide on-call psychiatry services for a twelve-month period at the Hilo Medical Center, Behavioral Health Facility (Hale Ho'ola). Dennis Lee, M.D. was appointed to the East Hawaii Region Board of Directors in 2008.

Hilo Medical Center serves a critical role in the delivery of behavioral health care needs for the east side of the Island of Hawaii ranging from Honokaa to the north and Pahala to the south. Two facilities in the region are Critical Access Hospitals, which serves as providers of patient care in its geographic service area. Because of the isolated location of the Hospitals, it has always had difficulty recruiting or retaining sufficient numbers of qualified physicians to provide the necessary coverage for its patients.

## The Scope of Services to be performed by Dennis Lee, M.D. includes:

Provide on-call psychiatric physician services at Hale Ho'ola, Behavioral Health facility at the Hilo Medical Center on an as needed basis. Services that are provided must comply with:

- 1. The policies, practices, and directions of the Hospital:
- 2. The Bylaws, Rules and Regulations of the Medical Staff;
- 3. The standards and recommendations of the Joint Commission;
- 4. The applicable standards of relevant professional societies; and
- 5. All applicable local, state, and federal laws and regulations.

## Time of Performance

The Time of Performance for this On-Call Psychiatric Physicians Agreement between Dennis Lee, M.D. and Hilo Medical Center shall be from November 14, 2010 until, up and including, November 13, 2011.

## **Contract Amount**

The Not to Exceed Value of the contract is One Hundred Thousand and 00/100 Dollars (\$100,000.00).

Anyone wishing to protest the award of this contract shall submit an objection, in writing, no later than 4:30 p.m. on Thursday, November 4, 2010, to:
