Notice to Award Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kona Community Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract to Rodger C. Kollmorgen, M.D., Ph.D., JD. to perform On Call Physician services for the Hospital's Inpatient Behavioral Health Unit at the Kona Community Hospital. Rodger C. Kollmorgen, M.D., Ph.D., JD. serves as an employee for the Hawaii Department of Health as an attending Psychiatrist.

Kona Community Hospital, the primary health care facility serving West Hawaii, is a 94-bed full service medical center located 18 miles south of Kona International Airport in Kealahou Hawaii. The Hospital is experiencing a shortage of physicians willing to take call coverage for the Behavioral Health Unit and has determined that Dr. McGrath best meets this need.

The Scope of Services to be performed by Rodger C. Kollmorgen, M.D., Ph.D., JD. includes:

Provide On Call coverage for the Behavioral Health Unit at Kona Community Hospital in accordance with the call coverage schedule established by the HOSPITAL.

Comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.
6. Respond to and be available in the Hospital as soon as possible within 30 minutes of the request to provide care for patients at the Hospital.

Time of Performance

The Time of Performance for this On Call Physician Agreement between Rodger C. Kollmorgen, M.D. and Kona Community Hospital shall be from April 16, 2011 until, and including, April 15, 2012 with two (2) one year options to extend.

Contract Amount


The Not to Exceed Value of the contract is Twenty Seven Thousand and 00/100 Dollars (\$27,000.00).
