## GOVERNOR APPOINTS RONALD YOSHIDA TO COMMISSION

#### 1999 ETHICS WORKSHOP SCHEDULE

The ethics workshops run from 9:00 a.m. to 12 noon. The workshops are open to all state officials and employees. There is no registration fee, but seating is limited and registration will be on a first-come-first-served basis. To register for an ethics workshop, contact your department personnel office.

The Commission encourages all state employees who have not attended an ethics workshop to register for one of our workshops this year.

Reminder to Lobbyists: Lobbying expenditures statements are due on February 1, 1999, covering the period from May 1 through December 31, 1998. Expenditures statements must be filed by lobbyists, persons who spend \$750 or more (excluding travel costs) in any six-month period lobbying, and persons who employ or contract for the services of lobbyists.

### STATE OFFICIALS AND EMPLOYEES BEGIN FILING 1999 FINANCIAL DISCLOSURE STATEMENTS

The Hawaii State Ethics Commission recently mailed financial disclosure forms to over 1,600 state legislators, department heads, board and commission members, and other state officials and employees who are required each year to file financial disclosure statements. Filers must report on their disclosure statements information about sources and amounts of income, ownership interests in businesses and real property, officer and director positions, clients represented before state agencies, and other financial interests.

The completed forms are due on June 1, 1999. Persons who do not file their financial disclosure statements on time will be fined \$50, and may receive additional daily fines for continued failure to file.

Many officials and employees have already started filing their annual disclosure statements with the Commission this year. We applied these early filers!

Reminder to Financial Disclosure Filers: Disclosure forms are due on June 1, 1999. Don't forget to sign and date your forms. Thank you for filing early!

Did you know. . .

. . . that the Hawaii State Constitution (Article XIV) requires all elected officials, all candidates for elective office, and other public officials and employees as provided by law to file financial disclosure statements? In addition to being a requirement of the State Ethics Code, financial disclosures by government officials are a constitutional mandate.
