**Notice to Award Contract**

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Hilo Medical Center ("HMC") a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract with Dennis Lee, MD. HHSC desires to award an Agreement to Dennis Lee, MD to provide consulting services to assist in the development of clinical order sets for HMC's new Electronic Medical Records system for Behavioral Health elements of the system. Dr. Lee was appointed to the Board of Directors of the East Hawaii Region of HHSC in 2008 and continues to serve in that role.

Hilo Medical Center went live with its new electronic medical records (EMR) system on May 1, 2010. Since that time, HMC has been improving the functionality of the system. HMC is now proposing to enter into agreements with six (6) physicians to assist with the completion of the required order sets for clinical use. These physicians represent the following areas of medicine: Behavioral Health, Family Medicine, Surgery, Pediatrics, Gynecology, and General Hospitalists.

**The Scope of Services to be performed by Dennis Lee, MD includes:**

Provide consulting services at Hilo Medical Center to revise and create clinical order sets for behavioral health use. Services that are provided must comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.

**Time of Performance**

The Time of Performance for this Physicians Consulting Services Agreement between Dennis Lee, MD and HMC shall be from approximately January 14, 2011 until, up and including, January 13, 2012.

**Contract Amount**

The Not to Exceed Value of the contract is Five Thousand and 00/100 Dollars (\$5,000.00).
