

Notice to Award Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kona Community Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract with Rodger C. Kollmorgen, M.D., Ph.D., JD.. HHSC desires to award an Agreement so as to allow Rodger C. Kollmorgen, M.D., Ph.D., JD. to perform Medical Director services for the Hospital's Inpatient Behavioral Health Unit at the Kona Community Hospital. Rodger C. Kollmorgen, M.D., Ph.D., JD. serves as a full time employee with the Hawaii Department of Health as an attending Psychiatrist.

Kona Community Hospital, the primary health care facility serving West Hawaii, is a 94-bed full service medical center located 18 miles south of Kona International Airport in Kealakekua Hawaii. The Hospital is in need of a Medical Director for the Behavioral Health Unit that is familiar with the legal system and has determined that Dr. Kollmorgen best meets this need.

The Scope of Services to be performed by Rodger C. Kollmorgen, M.D., Ph.D., JD. includes:

Provide Behavioral Health Medical Director services at Kona Community Hospital. To coordinate, supervise, and evaluate the medical services provided in the Department and operate the Department in compliance with:

- 1. The policies, practices, and directions of the Hospital:
- 2. The Bylaws, Rules and Regulations of the Medical Staff;
- 3. The standards and recommendations of the Joint Commission:
- 4. The applicable standards of relevant professional societies; and
- 5. All applicable local, state, and federal laws and regulations.

Time of Performance

The Time of Performance for this Medical Director Physician Agreement between Rodger C. Kollmorgen, M.D., Ph.D., JD. and Kona Community Hospital is anticipated to begin on July 1, 2011 until, and including. June 30, 2012 with one (1) one year options to extend this agreement.

Contract Amount

The Not to Exceed Value of the contract is Sixty Thousand and 00/100 Dollars (\$60,000.00).
