Notice to Award Contract

Pursuant to Section 84-15(a) (3), Hawaii Revised Statutes, the Hawaii Health Systems Corporation (hereinafter HHSC), on behalf of Kona Community Hospital a public body corporate and politic and an instrumentality and agency of the State of Hawaii, hereby gives notice of its intent to award a contract to Barry Jason Worchel, M.D. to provide On Call Physician services for the Hospital's Inpatient Behavioral Health Unit at the Kona Community Hospital. Barry Jason Worchel, M.D. serves as a Medical Director for the East Hawaii Mental Health Clinic Section of the Hawaii County Community Mental Health Center (HCCMHC), Hawaii District Health Office, Department of Health.

Kona Community Hospital, the primary health care facility serving West Hawaii, is a 94-bed full service medical center located 18 miles south of Kona International Airport in Kealahou Hawaii. The Hospital is experiencing a shortage of physicians willing to take call coverage for the Behavioral Health Unit and has determined that Dr. Worchel best meets this need.

The Scope of Services to be performed by Barry Jason Worchel, M.D. includes:

Provide On Call coverage for the Behavioral Health Unit at Kona Community Hospital in accordance with the call coverage schedule established by the HOSPITAL.

Comply with:

1. The policies, practices, and directions of the Hospital;
2. The Bylaws, Rules and Regulations of the Medical Staff;
3. The standards and recommendations of the Joint Commission;
4. The applicable standards of relevant professional societies; and
5. All applicable local, state, and federal laws and regulations.
6. Respond to and be available in the Hospital as soon as possible within 30 minutes of the request to provide care for patients at the Hospital.

Time of Performance


The Time of Performance for this On Call Physician Agreement between Barry Jason Worchel, M.D. and Kona Community Hospital shall be from October 17, 2011 until, and including, October 16, 2012 with one (1) one year option to extend.

Contract Amount

The Not to Exceed Value of the contract is Twenty-Six Thousand and No/100 Dollars (\$26,000.00).
