## Special Session Lobbying Reports Due October 2, 2017



Lobbying expenditures and contributions reports for the First Special Session of 2017 (convened on August 28, 2017, and

adjourned on September 1, 2017) must be filed with the State Ethics Commission by October 2, 2017.

Who must file: Reports must be filed by the following persons, but only if they engaged in lobbying activities on matters considered during the Special Session: (1) lobbyists; (2) individuals and organizations who spent \$1,000 or more from May 1, 2017 through September 1, 2017 for the purpose of lobbying; and (3) individuals and organizations who employed or contracted for the services of a lobbyist. Lobbyists and other persons who did not lobby or engage in lobbying activities on matters considered during the Special Session are not required to file a Special Session report.

**Period covered by the reports:** Reports for the Special Session must include lobbying expenditures and contributions for the period beginning May 1, 2017 through September 1, 2017.

What must be reported: Only expenditures and contributions that relate to matters considered during the Special Session must be reported.

Twitter: @HawaiiEthics If you award contracts for your state agency or have other duties relating to the procurement of goods and services, remember that in addition to the State's procurement laws, you must also comply with the State Ethics Code, Chapter 84, Hawaii Revised Statutes. Whether you are ordering office supplies on a state price list or soliciting bids for a construction contract, the State Ethics Code requires you to uphold the standards of ethical conduct that apply to all state employees. Here are a few ethics reminders for state procurement personnel:

<u>Conflicts of Interests.</u> Do not take state action affecting any business, including a vendor or contractor, if you or your spouse have a financial interest in the business. A "financial interest" includes, among other things: (1) owning a business (this includes owning stock in a business); (2) being employed by a business; and (3) serving as an officer or director of a business. For example, if your spouse is employed by a business that is seeking a contract from your agency, you must disqualify yourself from making any decisions or recommendations affecting the business.

<u>Gifts.</u> Do not accept any gifts from vendors or contractors who do business or are seeking to do business with your agency. Vendors sometimes bring sushi, manapua, pastries or other treats to state offices, or offer to buy lunch when meeting with their state clients. These gifts are prohibited and should be declined by state procurement personnel.



Vendors also sometimes send holiday gifts and gift baskets to their state clients, or invite their state clients to holiday parties featuring food and drinks, entertainment, and in some cases, door prizes. Again, these are prohibited gifts and should be declined.

<u>Fair Treatment.</u> Do not give preferential treatment or unwarranted advantages to any vendors, contractors, or other businesses. And do not use your state position when dealing with vendors or contractors to obtain special discounts or other personal benefits for yourself.

<u>Confidential Information</u>. Do not disclose any confidential information that you acquire in performing your state duties; do not use any confidential information to benefit anyone. For example, do not disclose confidential information to assist a business that is bidding on a contract to be awarded by your agency.
