I Spy a Conflict of Interest

Do you know how to recognize a conflict of interest? There are three conflicts of interests rules that apply to you:



First, you cannot take any action as a state employee affecting a business in which you (or your spouse/dependent child) have a

financial interest. A "financial interest" includes being employed by a business, owning a business, or serving as an officer or director of a business, and a "business" includes for-profit businesses and non-profit organizations. In other words, you cannot be on both sides of a deal – you cannot take action in your state capacity that affects your (or your spouse's) private business, private employer, or non-profit organization.

Second, you cannot create new conflicts. For example, if - in your state job - you have dealings with a private business, you cannot take a job with that private business.

Third, you cannot assist your private employer in matters before your own agency.

Some situations are more likely to involve conflicts of interests with your state position. If you find yourself in any of these situations, contact the State Ethics Commission's office for advice:

- 1. You have a part-time job with a business, or are thinking about applying for a parttime job with a business, and you may be in a position to take action as a state employee affecting that business. - 2. Your spouse has a job with a business and you may be in a position to take action as a state employee affecting that business.
- 3. You or your spouse own a business (this includes owning shares of stock in a business) and you may be in a position to take action as a state employee affecting that business.
- 4. You or your spouse serve on the board of directors (with or without pay) for an organization and you may be in a position to take action as a state employee affecting that organization.
- 5. You would like to start your own private business to assist clients in applying for permits, grants, or contracts from your state agency.
- 6. You would like to sell products or services to your state agency or apply on behalf of your own business for permits, grants, or contracts from your state agency.
