B. Deliberation and decision-making on proposed rules

6 Chair Graulty explained that the Commission had received late testimony from 7 Bob Toyofuku the evening prior, May 20, 2020. Chair Graulty questioned whether the 8 Commission could consider this testimony given that the official notice of public hearing 9 for the proposed administrative rules required receipt of all written testimony by 12 p.m. 10 on May 6, 2020.

Executive Director Gluck stated that he had requested feedback from the Department of the Attorney General regarding the acceptance of late testimony but had not received a response back as of the time of this meeting. However, given the benefit of public input, Executive Director Gluck recommended that the Commission allow the late testimony from Mr. Toyofuku.

18 Commissioner Fong moved and Commissioner DeGuzman seconded a motion 19 to allow the late testimony from Mr. Toyofuku to be considered by the Commission. The 20 motion carried (Graulty, Tschumy, DeGuzman, and Fong voting aye; Wood voting nay). 21

Executive Director Gluck stated that staff had reviewed Mr. Toyofuku's testimony and subsequently recommends an additional change to the proposed administrative rules.

Due to the late nature of the testimony, Chair Graulty requested that staff continue to conduct a further review of Mr. Toyofuku's comments and formally provide the Commission any new proposed language for consideration at a later time. Chair Graulty also requested that the Commission defer decision-making until a future date to allow ample time for analysis.

Executive Director Gluck stated that staff would provide updated materials in writing, so both the Commissioners and members of the public will able to review and comment on any new proposed changes if desired. Executive Director Gluck also stated that he will consult with Chair Graulty on an appropriate date to reschedule the decision-making meeting.

Vice Chair Tschumy made and Commissioner Fong seconded a motion to defer
 the approval of the proposed rules until a future date. The motion carried unanimously
 (Graulty, Tschumy, DeGuzman, Wood and Fong voting).

2 3 Executive Director Gluck reported that the Legislature was scheduled to convene 4 on May 21, 2020, and reopen in June, although he was unsure as to whether the 5 Legislature's reopening would be via special session or an extension of the 2020 6 regular session. Executive Director Gluck explained that nevertheless, the 7 Commission's bills relating to policy were not experiencing any forward movement at 8 this time. However, the budget bill, which makes appropriations for the legislative 9 branch for next year (FY2020-2021), was approved and signed by the Governor, with 10 the Legislature maintaining the ability to amend the budget next year if it deems 11 appropriate. 12

Re: Comments on Proposed Rules on Lobbying and Lobbyists

I am submitting my comments for the members of the Ethics Commission to consider at its meeting on Thursday, May 21, 2020. It has been about four (4) months since I appeared before you in January 2020 and want to, first of all, extend my thanks to the commission members for allowing me to make some comments and answer some questions at that time.

I have been lobbying at the Hawaii state legislature since 1984 and my comments and some suggestions are included below and relate specifically to Section 21-10 on Lobbying.

I. Section 21-10-1

I acknowledge and agree with the definition of "Direct Lobbying" in the context of when an individual is deemed to be actually lobbying which comports with HRS 97-1 and the definition of lobbying. However, what may need to be clarified is the second sentence where it states that direct lobbying includes "discussing existing or potential legislation or administrative rules," It is unclear to me whether this only applies when you are discussing potential legislation or rules with a legislator, employee, etc. of the legislature or an agency. What confused me is

that this segment of the sentence follows "drafting or submitting testimony" which is not usually discussed with members of the legislature and discussed and done primarily internally with persons in your organization. When members of a lobbying organization or firm meet, formally or informally, to discuss legislation or rules, <u>among themselves</u>, including strategy to pass or defeat legislation, I am assuming it was not your intent to consider this as Direct Lobbying. On the other hand, if the lobbyist or members of the firm are meeting with a client to discuss the legislation and strategy, was it the commission's intent to include this as direct lobbying even where there is no contact with any members of the legislature or agency? I am interpreting the words "Direct Lobbying" literally and happens when you are communication with a legislator or agency director or staff.

I raise this here because it affects how to report the compensation that a firm receives because close to 75-100% of the compensation may be attributable to lobbying depending upon what the intent is. If so this would be misleading to the public if the primary definition of "lobbying" is communication with a legislator to influence legislation and discussing matters internally should not be considered direct lobbying.

One example that was provided previously was when an organization research and write a paper on a proposal from another state and then decides, internally, to promote legislation based on that paper, this work is considered lobbying. I took issue with this example when no communication was made with any legislator or staff, etc. It was all internal within the organization or firm. *See Example 5 to 21-10-1*.

Because "lobbying" in Section 21-2 includes the definition in HRS 97-1<u>AND</u> includes direct lobbying it is crucial that the direct lobbying definition be as clear and specific as possible. I would be concerned if the intent is to include all internal discussions as direct lobbying.

II, Section 21-10-2 and Section 21-10-4 - Registration

Oftentimes a third party is paid to do research or assist in drafting legislation. I wanted to be certain that although Section 21-10-2 (b) (1) refers to "drafting and providing testimony" which may require registration, Section 21-10-4 seems to create the exception for a person who is hired to assist in drafting testimony and doing research on an issue provided that that third party does not meet or communicate with any official in the legislative or executive branch.

Also, the five day time frame may be too short. The lobbyist needs to have the client sign the form and oftentimes the lobbyist does not get the form back within 5 days.

III Section 21-10-7 and Section 21-10-8 - Reporting of Expenditures & Expenditures

Lobbyists and firms report compensation received on the basis of direct lobbying when the lobbyist is communicating with someone in the legislature or an agency to influence legislation. If a firm receives \$2000 per month and only spend one hour communicating with a legislators(s), neither the lobbyist nor the client reports \$2000 received, but rather a percentage of that total. I am assuming that this fits within the proposed rules. However, I do recognize that Section 21-10-8 refers to "discussing legislative strategy" and "monitoring the status of proposed legislation ..." It is unclear that when this strategy discussion or monitoring is done internally by the firm's staff and not with any legislator, whether it is considered an expenditure. Every firm needs to monitor legislation for the client to advise them on hearings, etc. This is all done electronically. Does the staff person's (receptionist/secretary) salary need to be reported as an expenditure? Thank you for allowing me to submit these comments and questions. Dear Chair Graulty, Vice Chair Tschumy, and Commissioners DeGuzman, Wood, and Fong,

My colleagues and I have had an opportunity to review the testimony submitted by Mr. Bob Toyofuku, Esq., regarding the proposed administrative rules on lobbying. I also had an opportunity to discuss the proposed rules with Mr. Toyofuku; Mr. Toyofuku had several questions as to how the rules would apply to different hypothetical scenarios, and I pointed Mr. Toyofuku to the relevant proposed rules that addressed his questions.

In response to Mr. Toyofuku's written testimony, staff recommends two edits to the proposed rules.¹ Staff believes that neither edit changes the overall purpose or substance of the rule being edited. Instead, these suggested edits provide some additional clarity as to the Commission's intent in promulgating rules regarding the Lobbyists Law:

1. **Proposed Edit:** In the definition of "Direct lobbying" in proposed Hawai'i Administrative Rules ("HAR") § 21-10-1, we recommend deleting the second sentence ("Direct lobbying includes but is not limited to drafting or submitting testimony; discussing existing or potential legislation or administrative rules; and advocating for the passage or defeat of any legislation or administrative rule.").

Rationale: HAR § 21-10-1 contains definitions of "Direct lobbying" and "Grassroots lobbying" to show that lobbying can be both direct and indirect, consistent with the definition of lobbying in Hawai'i Revised Statutes ("HRS") § 97-1. However, the second sentence of the definition of "Direct lobbying" is unnecessary: detailed explanations of which activities count towards the registration threshold, and which expenditures must be reported on periodic expenditure reports, appear in proposed HAR §§ 21-10-2 and 21-10-8. The second sentence of "Direct lobbying" was intended to be illustrative (rather than exhaustive), but Mr. Toyofuku's testimony suggests that it adds more confusion than

clarity. As such, staff recommends that this sentence be deleted for clarity; staff does not believe that the deletion will result in a substantive change to the proposed rule.

2. **Proposed Edit:** In proposed HAR § 21-10-7(b)(1)(C), we recommend adding the word "Total" before the word "Compensation."

Rationale: Addition of the word "total" will clarify that all expenditures to lobbyists for the purpose of lobbying must be reported; non-lobbying activities still do not need to be reported, as discussed in proposed HAR § 21-10-9(c). Staff believes that the rules are already clear that "total" compensation must be reported, *see*, *e.g.*, proposed HAR § 21-10-8(a) ("Expenditures made 'for the purpose of lobbying' means *all those expenditures in support of and in preparation for* direct lobbying or grassroots lobbying." (emphasis added)); however, addition of the word "total" in HAR § 21-10-7 may help to clarify this requirement for lobbyists.

The remainder of Mr. Toyofuku's comments are generally answered through application of the proposed rules. For example, the question regarding a research project that *might* be used for lobbying is dealt with by proposed HAR §§ 21-10-2(b)(2) and 21-10-8(b)(2). The question regarding flat-fee payment arrangements (page 3) is addressed by proposed HAR § 21-10-9. The question regarding background strategy discussions is addressed by applying HAR § 21-10-8(a)(3) and (b)(2). Mr. Toyofuku and I discussed that the proposed rules *will* change the ways that some lobbyists report clients' expenditures, and I assured Mr. Toyofuku that the Commission staff intends to spend significant effort to educate lobbyists regarding these new requirements upon enactment of any proposed rules.

Mr. Toyofuku's comment on page 3 of his memorandum, regarding the five-day period to register, is set by HRS § 97-2 (and, therefore, cannot be altered by these rules).

Staff respectfully recommends that the Commission incorporate the proposed edits set forth herein, approve the draft rules (as amended), and move forward with the rule-making process.

WHAT'S NEW: OIP COLLECTING COMMENTS FOR DRAFT LEGISLATION May 14, 2020

The COVID-19 pandemic, and the possibility of future crises, have changed many things forever, including some ways that government may be conducted. OIP is particularly interested in gathering information on how agencies and boards are changing their procedures to cope during the crisis, what works or did not work, and what changes to the law or resources they need to expand their ability to provide public access to government records and public meetings. OIP also wants to hear from the public about constructive suggestions to improve public access while maintaining health and safety.
