### Agenda Item No. I: Welcome to Commissioner Cynthia Thielen (2:49)

Executive Director Harris introduced Commissioner Cynthia Thielen and noted her extensive legislative experience and how much it could assist the Commission. Director Harris expressed he looked forward to working with her in the future.

Commissioner Thielen expressed her gratitude to the Governor for the nomination.

## Agenda Item No. II: Consideration and Approval of the Minutes of the July 19, 2023 Meeting (4:33)

Vice Chair McCarthy moved, and Commissioner Tobias seconded a motion to
approve the minutes of the July 19, 2023 meeting. The motion carried (Fong, McCarthy,
Tobias, Hong, and voting in the affirmative and Thielen excused).

23 Agenda Item No. III: Directors' Report (5:44)

25 Compliance Director Bonita Chang reported there was a significant increase in 26 the number of individuals completing the self-directed ethics training, largely due to the 27 Department of Education ("DOE") issuing reminders to DOE personnel at the start of the 28 new school year. Director Chang reported that over 18,000 individuals had completed 29 ethics training year to date. This number represents an almost 300% increase over the 30 previous year. She further noted that in one day alone, there were approximately 2,000 31 individuals who took the self-directed training. Several live training sessions with DOE 32 has also been scheduled for August. For the remainder of 2023, staff will continue to 33 work with the various agency and board contacts on outreach and training efforts. 34

Director Chang noted that in light of the disaster in Maui, staff is being mindful and sensitive that various agencies and boards may have been impacted by the fires and the recovery process.

Executive Director Harris emphasized that approximately 54% of state
 employees have completed a mandatory ethics training. He noted this tremendous
 accomplishment, while also recognizing many state employees still need to complete
 the training.

44 Chair Fong echoed Executive Director Harris' sentiments. He agreed that it was
45 great that we are getting the word out, but more work needs to be done.
46

Enforcement Director Kee Campbell reported that staff closed 85 matters and
 received 63 new matters. Director Campbell noted that among the new matters were six
 to seven Applications for Good Cause Exceptions to the Nepotism Law. He noted that
 the nepotism decisions are posted on the Commission's website.

6 Chair Fong acknowledged receiving a number of emails regarding the new
7 Nepotism Law. He noted that there is disappointment that the law only covers the
8 executive branch. Executive Director Harris noted that while the law does not include
9 the legislative or judicial branches, both the House of Representatives and Senate have
10 adopted rules prohibiting nepotism.

Vice Chair McCarthy asked about the nature of the good cause applications.
Director Campbell noted some people seek an exemption even though they have
already complied with the law. Another frequent situation is where there are a limited
number of applicants. He explained that each situation is fact specific and is decided on
a case-by-case basis.

18 Chair Fong asked if the increase in training completions has led to an increase in 19 complaints. Director Campbell replied that while the expectation would be to see an 20 increase, the actual numbers of matters has remained fairly consistent month to month. 21

Vice Chair McCarthy asked if an employee could be grandfathered in as a nepotism exception. Director Campbell replied that in instances where a person may be so specialized that they are the only person who can perform their position, that this may meet the good cause standard.

27 Executive Director Harris reported that there have been several inquiries related 28 to fundraising in support of Maui relief. He stated that an email alert was issued stating 29 that emergency proclamations allow for the use of state resources to fundraise for Maui 30 relief. Executive Director Harris cited the example of using the State Capitol to drop off 31 donations. Executive Director Harris noted that staff have also received several phone 32 calls about fundraising to support affected state employees. He stated that the advice 33 given is that it may be appropriate for an agency or division to inform existing 34 employees of an opportunity to contribute (similar to passing a hat for a retirement or 35 other celebration), however fundraising publicly and/or coercing employees to give would not be allowed. 36

Executive Director Harris reported that the Council on Governmental Ethics Laws
 (COGEL) Conference will take place in Kansas City in early December. Commissioners
 Hong and Tobias will attend along with Executive Director Harris, Enforcement Director
 Kee Campbell, and Staff Attorney Jennifer Yamanuha.

# Agenda Item No. IV: Status of the Ethics in Hawai'i Conference (September 1, 2023) (20:00) 3

Chair Fong thanked those who volunteered to assist with transportation of the neighbor island participants.

7 Executive Director Harris commended the staff for their work in putting together
8 the conference. He reported he hopes to have a final draft of the program out soon. He
9 noted that speakers at the event include the Lieutenant Governor, Honolulu Mayor,
10 Retired Judge Dan Foley, and U.S. Attorney Clare Conners as well as several state
11 agency heads.

13 Chair Fong echoed Executive Director Harris's praise of the staff. He noted that 14 last conference was 5 years ago and that this conference is being co-sponsored with 15 the Honolulu Ethics Commission.

Vice Chair McCarthy asked about the final program. Executive Director Harris
replied that the final draft of the program will be sent to the Commissioners. The final
version of the program will be printed and distributed on the day of the event.

21 Vice Chair McCarthy asked if it would be possible to participate virtually. 22 Executive Director Harris noted that the rooms for the large group meetings have the 23 capability for live streaming so it may possible. He noted that actively participating 24 virtually may not be possible because staff may not be available to moderate online. He 25 also noted that breakout sessions may not be live streamed because the rooms may not 26 be equipped to do so. Chair Fong noted that the rooms are used for Neighborhood 27 Board meetings and that hopefully we will have the same set up which would allow for 28 virtual participation.

- 29 30 Commissioner Tobias asked what the role of the Commissioners would be. 31 Executive Director Harris replied that Commissioner's role is to actively participate and 32 meet and build relationships with the members of the other boards and commissions. 33 Executive Director Harris noted that there is a scheduled breakout session for board 34 and commission members only. He reminded the Commissioners that they can talk 35 generally about things, but need to avoid discussing specific matters that may come 36 before the board due to Sunshine Law Restrictions. 37
- Chair Fong noted that conference is more about learning and absorbing from the other boards and commission as opposed to participating. He encouraged Commissioners to meet and have conversations with the neighbor island members.

# 43 Agenda Item No. V. Discussion of Ethics Oversight over the Judicial Branch 44 (27:50) 45

46 Executive Director Harris noted that this topic was brought up last meeting, the 47 idea was brought up to begin a conversation with Judiciary regarding ethics. He reported that in light of the Maui Disaster, that there has been no movement in this
 regard. He was hopeful that a meeting could be set up in the next couple weeks.

3

4 Chair Fong asked what kinds of oversight exist in other jurisdictions. Staff 5 Attorney Yamanuha replied other jurisdictions seem to have independent commissions 6 with oversight authority. She was unsure if there was any overlap between those 7 commissions and a statewide entity. She noted that there is no oversight of the U.S. 8 Supreme Court. Staff Attorney Yamanuha reported that the Hawai'i Judicial Code 9 applied to judges and justices. She further noted that there is some question about the 10 independence of the Commission on Judicial Conduct as they are appointed by the Supreme Court and do not seem to have a limit on the number of terms they can serve. 11 12 Staff Attorney Yamanuha noted that there may be a role for the Commission. She 13 stated that at this point, it would be best to meet with Judiciary and ask questions. 14 Recommendations may come later.

16 Chair Fong stated that his concern regarding this topic was about who has 17 oversight and that he is looking forward to the staff report on this matter.

Vice Chair McCarthy asked for clarification about who the Judicial Code applies
to. Staff Attorney Yamanuha clarified that the Judicial Code applies to judges and
justices.

23 Vice Chair McCarthy asked about the separation of powers between the judicial 24 and the executive branch. He noted that the judiciary may not appreciate oversight by 25 the executive branch. Executive Director Harris replied that the Commission is not a 26 part of executive branch but is an independent entity administratively attached to the 27 Legislature. He noted that the Commission does not have statutory jurisdiction over 28 judges and justices. He noted that employees of the judiciary are considered state 29 employees and are subject to the Commission's jurisdiction. Vice Chair McCarthy 30 expressed concern that judiciary may not welcome oversight by the Commission. 31 Executive Director Harris agreed and said that it would be more appropriate at this point 32 to provide advice and recommendations after better understanding the current ethics 33 programs in place.

34

Chair Fong suggested Vice Chair McCarthy be included in the group meeting
 with Judiciary. He noted Vice Chair McCarthy's experience as a former judge may prove
 valuable. Executive Director Harris replied that staff will look at ways to facilitate Vice
 Chair McCarthy's participation.

Commissioner Tobias asked if judiciary employees participate in ethics training sessions provided by the Commission. Staff Attorney Jennifer Yamanuha replied that judiciary employees are subject to the Ethics Code and therefore are required to complete ethics training. She noted that the exception is for judges and justices as they are not subject to the ethics code. Executive Director Harris added that the judiciary is supportive of ethics and our efforts. He noted that this contrasts with the U.S. Supreme Court.

Would like to see one line ethics training programs that other ethics boards can use. I would like to explore ways that ethics boards can proactively discover public corruption such as the permitting department cases in the news. In an Op Ed in July Randy Roth lamented that these cases were detected and prosecuted by federal agencies and not local law enforcement or ethics boards. I don't have an answer as to how, but would like to discuss the issue to see if there are ways for us to discover them. In the future, I'd like to hear from the state AG and special agent in charge of the FBI.						

I know food is not session content and you can't please everyone, but lunch issues I heard were:

How can we assist or better collaborate with other ethics agencies?

All ethics boards face the same issues. We need to use your platform to find ways where we can make use of each others' work - forms, training programs, reseach, etc. - available to every other board.

Might be wise to outline a model for ethic commissions that might help Hawai'i, Maui, and Kaua'i push for better funding that separates critical functions with high walls.

Am still learning.

Appreciate both State and City staffs for pulling off this conf. HNL EC may be able to spearhead a county-wide brochure or other publication. Overall, I think there are a lot of things like this that could be achieved with minimal collaboration.

Starting with a list serve of lobbyists would good. I think that we should have a web portal for all of the Ethics Committees in the state as well as the Elections Commision to announce what they would like to highlight

If you have it, please circulate a list of attendees with their contact information

Consultation services, having videos on different topics available for boards to view.

I think for the moment, we need to focus on ethics. Collaboration would be good in the future.
